# **ASHRAE Indiana Day on the Hill Event**

The Central Indiana Chapter held a Day on the Hill (DOTH) event at the Indiana Statehouse on Wednesday, February 21<sup>st</sup>, 2018. It was Indiana's first Day on the Hill event. Four volunteers attended: Jim Arnold, Andrew Cheung, Doug Fick, and Jim Scarborough

# **Statehouse Layout Background:**




Figure 1: How the Statehouse is split up.

The Indiana Assembly has a short session for 2018 and all member offices reside in the Statehouse. There are 50 State Senators and 100 Statehouse Representatives. At the time of this report, Indiana is well known as a Republican state. The Statehouse itself is split into quarters: Senate Republicans, House Republicans, Senate Democrats, and House Democrats. See Figure 1. The Senate and House offices have doorkeepers on the third floor that you must check in at before seeing a legislator. The offices are spread out across multiple floors once you enter through the doorkeeper's entrance. It is important to note that there is no particular layout to the legislators' offices after this point. Legislative assistants (LA's) and interns may represent more than one legislator, and legislators sit next to LA's as well as each other. In some cases, the House representatives sat three in a single office. There were other offices on the third and fourth floors in the south half of the building but it was unclear why they were separate from the other offices.

#### Planning:

The Indiana Statehouse is organized so that appointments must be made in advance to see a legislator. Because it was not feasible to meet all 150 legislators in a day, the DOTH efforts were directed to only those legislators that were involved with utility and/or environmental committees. See Table 1 for those contacted. With a more focused approach, we were able to make 45 phones calls and setup approximately 12 appointments. In addition, many of the LA's contacted setup appointments with additional legislators outside of our original scope.

In some cases, volunteers spoke with LA's or interns rather than the legislator themselves.

# Highlights:

- House Minority Leader Goodin was kind enough to meet with our volunteers and ask for 30 copies of all of our handouts in order to distribute to the rest of the Democratic caucus.
- Senator Buck gave us a contact in the Legislative Services Agency (LSA), George Angelon. The
  LSA is comprised of lawyers whose job it is to research information on subjects the legislators
  are unfamiliar with. By knowing how information is passed to Representatives and Senators,
  ASHRAE can be more effective at being a resource to the people who have the ears of the
  Indiana legislators. Senator Buck also suggested we focus on the public heath committees for
  the next time.
- Representative Errington and Hamilton were very happy to meet us and asked many questions regarding how we operate and what we do.
- Representative Frye could not attend our meeting, but we were able to meet with his LA. His LA
  sits on the utilities committee and was more than happy to pass our information along to the
  committee members. She also recommended particular members of Congress to contact.

### **Key Lessons:**

- Since LA's and their interns are the ones who set the appointments of legislators, it is important to be extremely polite to them. Furthermore, it is worth creating a contact spreadsheet list of which LA represents which legislator. This helps in making fewer phone calls and helps you create a manageable system of setting up appointments.
- Our message is pure and thus, many legislators were very responsive. They cared that we did
  not want anything except to help them the next time they needed expert technical knowledge
  on topics within the ASHRAE standards scope.
- Write thank you follow up letters and debrief with volunteers so you have specific information you can put in the thank you letters to make them more personal.
- The legislative process is chaotic. Schedules change at a moment's notice. Therefore, it is vital to be able to answer your phone at all times in case a legislator's schedule frees up. In our case, the meeting with House Minority Leader Goodin was completely impromptu. His LA saw an opening in the schedule and called, asking if we had volunteers who could meet immediately. Luckily, we were in between appointments and could make it.
- Go to the DOTH event early and/or the week before so you are familiar with the layout of the building. Be sure you know how the offices are laid out as well. We were lucky enough to only have four volunteers, so it was easy to split up in groups of two and sit in the legislator's offices. Any more than two volunteers to a legislator would have been very cramped in some cases. If you are unsure, you should ask one of the LA's when you are scheduling the appointments.
- Coordinating multiple appointments requires you to know all volunteers ahead of time. Be sure
  to send out outreach emails early and also request that the word be spread during chapter
  meetings.
- It was recommended that we have high quality folders and pamphlets created so that our marketing collateral materials seem more professional.
- The Democrats seemed to be more receptive to our message than the Republicans.
- Do not call a Senator a Representative and vice versa.

The only follow up with the senators and representatives completed was a personalized thank you letter. However, there were follow up items that came from the Day on the Hill coordination, including contacting the LSA, writing a DOTH report, and debriefing with the rest of the Central Indiana Chapter board members.

The first Indiana Day on the Hill event went well. We were able to pass along the ASHRAE message and have our presence known. Next year, we will plan earlier, and target different committees while making sure we make a point to talk to specific LA's and interns. That way they will be more receptive for every subsequent DOTH hereafter.
