

KBIM™ TEMPLATE END USER LICENSE AGREEMENT

IMPORTANT: THIS END USER LICENSE AGREEMENT (“EULA”) IS A LEGAL AGREEMENT BETWEEN THE PERSON, COMPANY, OR ORGANIZATION THAT HAS LICENSED THIS KBIM TEMPLATE (“YOU”) AND KARPINSKI ENGINEERING, INC., 3135 EUCLID AVENUE, CLEVELAND, OH 44115 (“KARPINSKI”) AND AMERICAN SOCIETY OF HEATING, REFRIGERATING AND AIR-CONDITIONING ENGINEERS, INC. 1791 TULLIE CIRCLE, N.E. ATLANTA, GA 30329 (“RETAIL LICENSEE”). READ THIS AGREEMENT CAREFULLY BEFORE COMPLETING THE INSTALLATION PROCESS AND USING THE KBIM TEMPLATE. BY INSTALLING AND/OR USING THE KBIM TEMPLATE, YOU ARE ACCEPTING THE KBIM TEMPLATE, CONFIRMING YOUR ACCEPTANCE OF THE KBIM TEMPLATE, AND AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS, OR DO NOT HAVE AUTHORITY TO AGREE TO BE BOUND TO THESE TERMS, DO NOT INSTALL AND/OR USE THE KBIM TEMPLATE AND RETURN THE KBIM TEMPLATE TO YOUR PLACE OF PURCHASE FOR A FULL REFUND IN ACCORDANCE WITH ITS REFUND POLICIES.

THIS EULA SHALL APPLY ONLY TO THE KBIM TEMPLATE SUPPLIED BY KARPINSKI OR RETAIL LICENSEE HEREWITH REGARDLESS OF WHETHER ANOTHER TEMPLATE OR OTHER SOFTWARE IS REFERRED TO OR DESCRIBED HEREIN.

1. DEFINITIONS

- a) “Karpinski” means Karpinski Engineering, Inc.
- b) “Retail Licensee” means American Society of Heating, Refrigerating and Air-Conditioning Engineers, Inc. American Society of Heating, Refrigerating and Air-Conditioning Engineers, Inc. is authorized by Karpinski to sell licenses to the KBIM Template to end users.
- c) “KBIM Template” means the Karpinski template file(s), supplied by Karpinski or its Retail Licensee herewith, and corresponding documentation, associated media, printed materials, and online or electronic documentation. KBIM Template shall also include any updates to the KBIM Template that have been provided to you or may be provided to you in the future by Karpinski or its Retail Licensee. KBIM is a trademark of Karpinski.

2. LICENSE GRANTS

The licenses granted by Karpinski in this Section are subject to the terms and conditions set forth in this EULA:

- a) Subject to Section 2(b), you may install and use a single copy of the KBIM Template on a single computer; **OR** install and store a single copy of the KBIM Template on a network storage device, such as a network server, for access and use by individual computers over an internal network.
- b) In the event that the KBIM Template is installed and stored on a network storage device for access and use by individual computers over an internal network, the KBIM Template shall only be made accessible for use by a maximum of 100 individual computers. Additional license(s) for the KBIM Template is required if the KBIM Template is installed

and stored on a network storage device and is accessible for use by more than 100 individual computers.

- c) You may make modifications to the single copy of the KBIM Template permitted to be installed per the terms of Sections 2(a) and 2(b). Modifications include additions, customizations, library alterations, and the like. Any modifications made by you shall be done at your own risk without the expectation that Karpinski or its Retail Licensee has any liability to assist you in restoring the KBIM Template to its original condition. Modifications to the KBIM Template to remove any trademark, trade name, product name, logo, copyright or other proprietary notices, legends, symbols or labels in the KBIM Template is prohibited.
- d) You may make one copy of the KBIM Template in machine-readable form solely for backup purposes. You must reproduce on any such copy every trademark, trade name, product name, logo, copyright or other proprietary notices, legends, symbols or labels in the KBIM Template. You may not sell or transfer any copy of the KBIM Template made for backup purposes.
- e) Your license rights under this EULA are non-exclusive.

3. LICENSE RESTRICTIONS

- a) Other than as set forth in Section 2, you may not make or distribute copies of the KBIM Template, or electronically transfer the KBIM Template from one computer to another or over a network.
- b) You may not rent, lease, or sublicense the KBIM Template.
- c) You may not export the KBIM Template into any country prohibited by the United States Export Administration Act and the regulations thereunder.
- d) In the event that you fail to comply with this EULA, Karpinski may terminate the license and you must destroy all copies of the KBIM Template (with all other rights of all parties to this EULA and all other provisions of this EULA surviving any such termination).

4. UPDATES

If this copy of the KBIM Template is an update from an earlier version of the KBIM Template provided to you as a result of your prior purchase of an earlier version of the KBIM Template, you must possess a valid full license to such copy of the earlier version of the KBIM Template used to update to this update copy in order to install and/or use this update copy. You may continue to use each earlier version copy of the KBIM Template to which this update copy relates on your computer or network storage device after you receive this update copy, provided that, (i) the update copy and the earlier version copy are installed and/or used on the same computer or network storage device only, and the earlier version copy is not installed and/or used on any other computer or network storage device; (ii) you comply with the terms and conditions of the earlier version's end user license agreement with respect to the installation and/or use of such earlier version copy; and (iii) you acknowledge and agree that any obligation Karpinski or its Retail Licensee may have to support and/or offer support for the earlier version of the KBIM Template may be ended.

5. OWNERSHIP

The foregoing license gives you limited license to use the KBIM Template. Karpinski retains all right, title and interest, including all copyright and intellectual property rights, in and to, the KBIM Template (as an independent work and as an underlying work serving as a basis for any work you may develop), and all copies thereof. All rights not specifically granted in this EULA, including Federal and International Copyrights, are reserved by Karpinski.

6. LIMITED WARRANTY AND DISCLAIMER

- a) Karpinski warrants that, for a period of ninety (90) days from the date of delivery (as evidenced by a copy of your receipt), when used with a recommended hardware and software configuration, the KBIM Template will perform in substantial conformance with the documentation supplied with the KBIM Template;
- b) Retail Licensee warrants that, for a period of ninety (90) days from the date of delivery, the physical media on which the KBIM Template is furnished will be free from defects in materials and workmanship under normal use.
- c) **KARPINSKI AND ITS RETAIL LICENSEE DISCLAIM ALL WARRANTIES AND REPRESENTATIONS, WHETHER EXPRESS, IMPLIED, OR OTHERWISE, INCLUDING THE WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. ALSO, THERE IS NO WARRANTY OF NON-INFRINGEMENT, TITLE OR QUIET ENJOYMENT. KARPINSKI AND ITS RETAIL LICENSEE DO NOT WARRANT THAT THE KBIM TEMPLATE IS ERROR-FREE OR WILL OPERATE WITHOUT INTERRUPTION. NO RIGHTS OR REMEDIES REFERRED TO IN ARTICLE 2A OF THE UCC WILL BE CONFERRED ON YOU UNLESS EXPRESSLY GRANTED HEREIN. THE KBIM TEMPLATE IS NOT DESIGNED, INTENDED OR LICENSED FOR USE IN HAZARDOUS ENVIRONMENTS REQUIRING FAIL-SAFE CONTROLS, INCLUDING WITHOUT LIMITATION, THE DESIGN, CONSTRUCTION, MAINTENANCE OR OPERATION OF NUCLEAR FACILITIES, AIRCRAFT NAVIGATION OR COMMUNICATION SYSTEMS, AIR TRAFFIC CONTROL, AND LIFE SUPPORT OR WEAPONS SYSTEMS. KARPINSKI AND ITS RETAIL LICENSEE SPECIFICALLY DISCLAIMS ANY EXPRESS OR IMPLIED WARRANTY OF FITNESS FOR SUCH PURPOSES.**
- d) **IF APPLICABLE LAW REQUIRES ANY WARRANTIES WITH RESPECT TO THE KBIM TEMPLATE, ALL SUCH WARRANTIES ARE LIMITED IN DURATION TO NINETY (90) DAYS FROM THE DATE OF DELIVERY.**
- e) **NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY KARPINSKI, ITS RETAIL LICENSEES, DEALERS, DISTRIBUTORS, AGENTS OR EMPLOYEES SHALL CREATE A WARRANTY OR IN ANY WAY INCREASE THE SCOPE OF ANY WARRANTY PROVIDED HEREIN.**
- f) **(USA only) SOME STATES DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER LEGAL RIGHTS THAT VARY FROM STATE TO STATE.**

7. EXCLUSIVE REMEDY

Your exclusive remedy under the preceding is to return the KBIM Template to the place you acquired it, with a copy of your receipt and a description of the problem. Provided that any non-

compliance with the above warranty is reported in writing to Karpinski or its Retail Licensee no more than ninety (90) days following delivery to you, Karpinski or its Retail Licensee will use reasonable commercial efforts to supply you with a replacement copy of the KBIM Template that substantially conforms to the documentation, provide a replacement for defective media, or refund to you your purchase price for the KBIM Template, at its option. Karpinski and its Retail Licensee shall have no responsibility if the KBIM Template has been altered in any way, if the media has been damaged by misuse, accident, abuse, modification or misapplication, or if the failure arises out of use of the KBIM Template with other than a recommended hardware or software configuration. Any such misuse, accident, abuse, modification or misapplication of the KBIM Template will void the warranty above. THIS REMEDY IS THE SOLE AND EXCLUSIVE REMEDY AVAILABLE TO YOU FOR BREACH OF EXPRESS OR IMPLIED WARRANTIES WITH RESPECT TO THE KBIM TEMPLATE AND RELATED DOCUMENTATION.

8. LIMITATION OF LIABILITY

- a) **NEITHER KARPINSKI NOR ITS RETAIL LICENSEE SHALL BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY INDIRECT, SPECIAL, INCIDENTAL, PUNITIVE, COVER OR CONSEQUENTIAL DAMAGES (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR THE INABILITY TO USE EQUIPMENT OR ACCESS DATA, LOSS OF BUSINESS, LOSS OF PROFITS, BUSINESS INTERRUPTION OR THE LIKE), ARISING OUT OF THE USE OF, OR INABILITY TO USE, THE KBIM TEMPLATE AND BASED ON ANY THEORY OF LIABILITY INCLUDING BREACH OF CONTRACT, BREACH OF WARRANTY, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR OTHERWISE, EVEN IF KARPINSKI OR ITS RETAIL LICENSEE HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND EVEN IF A REMEDY SET FORTH HEREIN IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.**
- b) **KARPINSKI'S AND ITS RETAIL LICENSEE'S TOTAL LIABILITY TO YOU FOR ACTUAL DAMAGES FOR ANY CAUSE WHATSOEVER WILL BE LIMITED TO THE AMOUNT PAID BY YOU FOR THE KBIM TEMPLATE THAT CAUSED SUCH DAMAGE.**
- c) **(USA only) SOME STATES DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU AND YOU MAY ALSO HAVE OTHER LEGAL RIGHTS THAT VARY FROM STATE TO STATE.**
- d) **THE FOREGOING LIMITATIONS ON LIABILITY ARE INTENDED TO APPLY TO THE WARRANTIES AND DISCLAIMERS ABOVE AND ALL OTHER ASPECTS OF THIS EULA.**

9. BASIS OF BARGAIN

The Limited Warranty and Disclaimer, Exclusive Remedy and Limitation of Liability set forth above are fundamental elements of the basis of this agreement. Karpinski would not be able to provide the KBIM Template on an economic basis without such limitations. Such Limited Warranty and Disclaimer, Exclusive Remedy and Limitation of Liability inure to the benefit of Karpinski's Retail Licensee.

10. GENERAL

This EULA shall be governed by the internal laws of the State of Ohio, without giving effect to principles of conflict of laws. You hereby consent to the exclusive jurisdiction and venue of the state courts sitting in Cuyahoga County, Ohio or the federal courts in the Northern District of Ohio to resolve any disputes arising under this EULA. In each case this EULA shall be construed and enforced without regard to the United Nations Convention on the International Sale of Goods.

This EULA contains the complete agreement between the parties with respect to the subject matter hereof, and supersedes all prior or contemporaneous agreements or understandings, whether oral or written. You agree that any varying or additional terms contained in any purchase order or other written notification or document issued by you in relation to the KBIM Template licensed hereunder shall be of no effect. The failure or delay of Karpinski or its Retail Licensee to exercise any of its rights under this EULA or upon any breach of this EULA shall not be deemed a waiver of those rights or of the breach.

You are not authorized to make any amendment to this EULA unless such amendment is in writing and signed by a duly authorized representative of Karpinski.

If any provision of this EULA shall be held by a court of competent jurisdiction to be contrary to law, that provision will be enforced to the maximum extent permissible, and the remaining provisions of this EULA will remain in full force and effect.

Trademarks contained in the KBIM Template are trademarks or registered trademarks of Karpinski, Inc. in the United States and/or other countries. Third party trademarks, trade names, product names and logos may be the trademarks or registered trademarks of their respective owners. You may not remove or alter any trademark, trade name, product name, logo, copyright or other proprietary notices, legends, symbols or labels in the KBIM Template. This EULA does not authorize you to use Karpinski's name or any of its respective trademarks.
