## FOREWORD

Currently in the industry there is a discrepancy between ASHRAE standards and AAMI standards in several requirements for environmental conditions in areas of the Sterile Processing Department (SPD). ASHRAE standards guide the design of these areas, while AAMI standards guide their operation. Therefore, some amount of agreement is required between the two. In April of 2015, representatives of ASHRAE, AAMI, FGI, AORN, ASHE, and APIC met to discuss these issues. Addendum h represents this group's recommendations for space temperature in several spaces. Additionally, a note has been added to the standard referring users to the corresponding AAMI document, which includes additional require ments to consider.
