INTERPRETATION IC 62-2001-50 OF ANSI/ASHRAE STANDARD 62-2001 (Addendum "n") VENTILATION FOR ACCEPTABLE INDOOR AIR QUALITY

Reference: This request for interpretation refers to Addendum "n" to ANSI/ASHRAE Standard 62-2001 that incorporates a new Ventilation Rate Procedure in Section 6.2, specifically Section 6.2.4.2 and Appendix G (and the VRP Excel Spreadsheet 2005119121636_347.xls).

Background: Addendum "n" to 62-2001 revises the ventilation rate procedure. One of the key components is the determination of the *system ventilation efficiency*, *Ev*, which can be determined from Table 6.3, or Appendix G. Table 6.3 provides a direct determination of *Ev* based on the maximum *zone primary outdoor air fraction*, *Zp*. Appendix G utilizes the minimum *zone ventilation efficiency*, *Evz*, of all zones serves by a particular unit. Equation G-2 provides a generalized form of the equation to determine *Evz*. Within *Evz*, the fraction of supply air to the zone from outside sources, *Fa*, is to be determined, which in turn relies on the determination of the primary air fraction to the zone, *Ep*. *Ep* is defined as *Vpz/Vdz*, where *Vpz*, the zone primary air flow, is defined in Section 6.2.4.1. However, *Vdz* is not defined. In Section 6.2.4.1 *Vpz* for VAV systems is to be the minimum expected primary air flow. However, in the VRP Excel spreadsheet provided by ASHRAE (Appendix G tab) the notes indicate that *Vpz* is to equal the design air flow.

<u>Interpretation No. 1:</u> *Vpz* for VAV systems, whether in 6.2.4.1, or Appendix G, is to be the minimum expected primary air flow (i.e. the lowest setting for the VAV box).

Question No. 1: Is this Interpretation correct?

Answer No. 1: Yes

<u>Comments No. 1</u>: Of course if the VAV box never reaches its minimum airflow setpoint at ventilation design conditions, *Vpz* may be higher than this minimum setpoint.

<u>Interpretation No. 2:</u> *Vdz* is the zone discharge (supply) airflow to the zone that includes primary and locally recirculated airflow. With VAV systems this shall be *Vpz* plus the recircualted airflow when *Vpz* is at the expected minimum.

Question No. 2: Is this Interpretation correct?

Answer No. 2: Yes

Comments No. 2:
