Dear Chair Niemeyer:

We are writing to you regarding Senate Bill 335, "Climate Solutions Task Force". ASHRAE supports the inclusion of "encouraging the construction of buildings that meet the current energy standards of ASHRAE" as one of the primary areas of focus of the proposed Task Force. ASHRAE develops and publishes robust consensus-based standards, many of which are adopted into building codes. Our standards establish recommended practice in the areas of indoor air quality, energy conservation and management, building water systems, high-performance buildings and others. ASHRAE standards are developed by knowledgeable and skilled volunteers from around the globe under strict ethical and non-commercialism guidelines.

Additionally, ASHRAE is committed to a leadership role in reducing climate change contributed to by building systems and responding to climate change experienced in the built environment.
