Background: Mr. Taft filed a complaint for action/inaction against SSPC 62.1 regarding actions taken by the committee. A. Disaster Response

B. Carbon Ad Hoc

M3 It was moved by Doug Fick and seconded by Charlie Culp that:

Technology Council create an Ad Hoc Committee to develop a method to calculate carbon equivalent emissions for all applicable ASHRAE Standards. Report can be found on *Basecamp at ASHRAE Technology; Docs & Files; Meetings; 2019_06_11 Pre-Kansas City Meeting.*

Background: Carbon (Carbon equivalent emissions) is becoming a popular metric for the built environment. It is referenced throughout our documents and standards. The executive committee has identified a potential issue with the application of carbon which should be addressed. Standards 105 and 189.1 and 189.3 currently have definitions of carbon in their documents. Standards 90.1, 90.2 and 90.4 are in the early process of determining how this will be incorporated into their standards and into the Appendix G process (90.1). This Ad Hoc is being asked to determine the process to calculate carbon not how the respective standard would apply. It is recommended that the group include but not be limited to representatives from these referenced standards. We anticipate this to be of limited scope and duration requiring flexibility greater than a formal group. We anticipate a white paper with options that the standards could utilize for their situation.

This Ad Hoc shall provide a recommended process for distribution and a draft implementation plan for the impacted standards.
