

## YEA Leadership Weekend Policies

### **Registration**

YEA Leadership Weekend attendance is limited to 30 members. To be fair to all registrants, completed forms are processed on a first-come, first-served basis. Payment is required at the time of registration. After 30 completed and paid registrations have been received, registration will be closed and a waiting list will be created until the registration deadline of **Thursday, February 1<sup>st</sup>, 2024**.

The online registration form must be completed in its entirety and submitted online for your registration to be received and processed. You will receive a confirmation email from Jeanette McCray at [jmccray@ashrae.org](mailto:jmccray@ashrae.org) (or another ASHRAE Staff) once your registration is processed. We will not be able to accommodate any attendees who did not register for the event.

### **Schedule and Travel**

Please wait to purchase airfare until you have heard from ASHRAE Staff that your application has been received and payment has been processed.

- For those **not** participating in the technical tour: When you are ready to book flights, make sure you will be landing in Mexico City, Mexico no later than 12:30pm local time on Friday, March 22, 2024 and departing no earlier than 2:00pm local time on Sunday, March 24, 2024. This will allow time to travel between the airport and hotel without missing any of the scheduled events.
- For those **participating** in the technical tour: When you are ready to book flights, please plan on arriving in Mexico City, Mexico at any time before 2:00pm Thursday, March 21, 2024 (your hotel room will be ready beginning at 4pm that day, but since the tour is at 3:00pm you can arrive early and store your bags at the hotel). Please book your departing flight no earlier than 2:00pm local time on Sunday, March 24, 2024. This will allow time to travel between the airport and hotel without missing any of the scheduled events.
