# Main Project Committee Meetings (SSPCs, SPCs, GPCs, SGPCs)

• If your committee chooses to host a hybrid meeting, the committee must provide their own meeting link. A USB plug-in speaker/microphone is available <u>upon request</u> to help support your hybrid meeting. Please note, this equipment is best suited for smaller rooms and may not function effectively in large meeting spaces.

# Subcommittee Meetings

- Subcommittees who wish to meet virtually in advance should schedule to meet any time before January 30<sup>th</sup>. The subcommittee must provide their own link to host the virtual meeting and submit it through the portal to have the meeting listed on the conference schedule.
- It is strongly encouraged that PC subcommittees meet virtually in advance of the Conference. Subcommittees may submit requests to meet in-person at the Winter Conference, but space is limited and may not be available.
- Hybrid subcommittee meetings will not be approved for the Winter Conference. If members cannot attend in-person, the subcommittee should meet virtually in advance of the Conference.
- Following the 2026 Winter Conference, SSPCs, SPCs, GPCs, SGPCs, subcommittees will no longer be
  permitted to request an in-person meeting space at conferences due to rising costs and the need to
  optimize the use of conference time and meeting space. Hosting virtual meetings prior to the
  conference ensures all interested parties can attend with clear dialogue and equal access. It also
  provides attendees with greater flexibility to participate in Technical Sessions, the Expo, and other
  Society meetings and events while on-site.

- All requests must be submitted by August 22<sup>nd</sup>.

- On the details page, you will be able to request any of the following:
  - o Screen
  - Power Strips
  - Dual USB Plug-In Microphone/Speaker (main committees only)
  - Projectors will not be available.
- If you plan to have a hybrid or virtual meeting, you must link your meeting at the time of the request. If the link is not provided, the meeting will automatically be scheduled as an in-person meeting.
