This second publication public review (2nd PPR) draft proposed revisions to the published text of Standard 15-2022, and shows proposed changes to the current standard, rather than proposed changes to the previous 1st PPR draft. Additional modifications to the proposed text have been drafted in response to comments which were received during the 1st PPR period of the proposed addendum.
