Addendum b modifies the standard to make it consistent with the *The International Mechanical Code*<sup>®</sup> (IMC) and NFPA 96.

*Note:* In this addendum, changes to the current standard are indicated in the text by <u>under-</u> <u>lining</u> (for additions) and <del>strikethrough</del> (for deletions) unless the instructions specifically mention some other means of indicating the changes.

#### Addendum b to Standard 154-2016

**5.6.1** Exhaust systems shall be designed to prevent re-entrainment into building intakes. Prevailing winds and velocities shall be considered when locating intake and exhaust openings. The minimum horizontal distance between discharge and intake shall be 10 ft (3 m). Where this horizontal distance is not achievable, the exhaust shall discharge a minimum of 2 ft (0.6 m) 3 ft (0.9 m) above any outdoor air intake. Exhaust discharge shall not impinge on overhangs, parapets, other equipment, or higher parts of buildings.
