Addendum q to ASHRAE Standard 154-2016 modifies existing defined term "demand-control ventilation (DCV)" to be "demand-controlled kitchen ventilation (DCKV)." Addendum o updates use of the term in Sections 7.1.2, 7.1.2.1, and 7.1.2.4 accordingly.

Addendum o to Standard 154-2016

Modify Section 7 as shown.

7.1.2 Demand-Controlled Kitchen Ventilation

7.1.2.1 The exhaust flow rate is permitted to be reduced during partial load cooking and when there is no cooking through the means of demand-controlled kitchen ventilation.

[. . .]

7.1.2.4 Demand-controlled kitchen ventilation (DCKV) systems shall be designed and part of a listed hood for the purpose of modulating exhaust airflows, or shall be engineered.
