FOREWORD

Addendum y adds language to Section 8.3.1.7 to prohibit vaping. These changes do not add cost or scope to the existing language of the standard.

Note: In this addendum, changes to the current standard are indicated in the text by <u>underlining</u> (for additions) and <u>strikethrough</u> (for deletions) unless the instructions specifically mention some other means of indicating the changes.

Addendum y to Standard 189.1-2020

Modify section 8.3.1.7 as shown.

8.3.1.7 Environmental Tobacco Smoke Smoking and Vaping

- a. Smoking <u>and vaping</u> shall not be allowed<u>be prohibited</u> inside the building. Signage stating such shall be posted within 10 ft (3 m) of each building entrance.
- b. Any exterior designated smoking or vaping areas shall be exterior to the building and shall be located not less than a minimum of 25 ft (7.5 m) away from building entrances, outdoor air intakes, and operable windows.
